Question: May a for-profit or non-profit corporation draft articles of incorporation for a new Kentucky corporation when the drafter has no beneficial interest in the new entity?

Answer: No.

OPINION

Drafting articles of incorporation is unquestionably the practice of law. See KBA U-7. Where the drafter has no beneficial interest in the new entity, the drafter must be an attorney licensed in Kentucky or he/she cannot prepare the articles without engaging in the unauthorized practice of law.

Furthermore, corporations are not permitted to practice law in the Commonwealth. <u>Kentucky Bar Association v. Tussey</u>, Ky., 476 S.W.2d 177 (1972); KBA U-32; <u>Kentucky Bar Association v. Legal Alternatives</u>, Inc., Ky., 792 S.W.2d 368 (1990).
