3. Membership Drive

We have received some information that requested from the Bar Association. We now know that there are a total of 996 YLD members. There are a total of 4202 that are eligible

to be YLD Members who are members of the KBA, which means there is a total of 3206 eligible to join YLD who are otherwise not members. That give us a 23.70% member to eligible member ratio, roughly 1 in 4 of those eligible to be a YLD member is. If we had 100% membership of those eligible to be a YLD member, YLD's membership would comprise 21.26% of the bar of 1/5 of the total bar membership.

Just to point this out at our current membership level of 996 people, at \$20 a person, that is a total income of \$19,920. If we had all 4202 join as members at \$20 a piece that would be a total income of \$84,040. Which means we are missing out on \$64,120.00 worth of dues revenue.

I have requested some additional information from the Bar, including: (1) List of names of those who are eligible to join; (2) everyone's age; (3) Date they joined the bar; and (4) email addresses for both those YLD members and those Eligible to join YLD. Still waiting to hear back on this.

4. Policy on Speakers

All speakers on behalf of YLD would need to sign our agreement that says they will remain non-partisan if they are going to speak at our event. This should protect us going forward and make our speakers aware that they can't do certain things.

Motion to make this a policy rather than an engagement letter.

Motion was made by Sebastian Torres, Seconded by Elivia Rabe. Motion Passed. This policy is approved as a policy. To be posted on our website.
